KEY Responsibilities

Core

- Tested cellular phones using various mechanical and computerized test equipment and report to customer.

- Test semiconductors to the required specifications and setup test equipment.
- Operate well test equipment to include monitoring controls and instruments and recording the data.
- Operate and set-up electrical test equipment to test ready-made chips.
- Load and unload product in test equipment and verified results.
- Operated high- speed test equipment to test integrated circuits.
- Test various micro chips in automated test equipment.
- Test Integrated Circuits using test equipment.
- Analyzed faults indicated by test equipment.
- Use computerized test equipment to test cellular phones
- To make the inspection to all equipment and update the concern if any maintenance required.
- Keeping all equipment in validated stage.
- Keeping all documents online.
- Documentation of all work/activities.
- Keeps equipment operating by enforcing operating instructions; troubleshooting breakdowns; requiring preventive maintenance; calling for repairs.

EHS

- Actively participates in the development and implementation of EHS objectives & programs, and lead EHS audits / inspections. Take a major role in incident reporting & investigation.

Business Continuity

- Attend and actively participate in all business continuity training and awareness programs.
- Understand the facility's business continuity plans and procedures.
- Act according to the emergency response procedures during drills and actual events.
- Report any observed risks or potential threats to the continuity of operations to the designated officer.
- Adhere to data protection policies to ensure the integrity and confidentiality of sensitive information.
- Acknowledge roles and responsibilities during an incident to ensure effectiveness by understanding the business continuity programme.
- Recognize an incident or crisis.
- Alert incident or crisis responders (including emergency responders as appropriate).
- Escalate action to the incident or crisis management team.
- Respond appropriately to specific threats.
- Respond appropriately when evacuated from the site.
