Additional Information and Charges Applicable

Weight Information : Chargeable weight will be actual or volumetric weight whichever is higher. Volumetric Weight will be calculated as:

$$\text{Length} \times \text{Width} \times \text{Height (Centimeters)} / 5000 = \text{Volumetric Weight in Kilograms.}$$

Fuel Surcharge : Fuel Surcharges will be applied as per fuel index informed to you on a monthly basis
