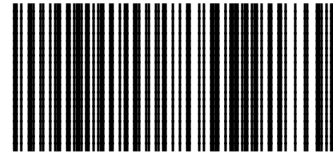

**SMSA EXPRESS**  
**TERMS AND CONDITIONS OF DOMESTIC CARRIAGE**

This shipment is accepted by SMSA Express by its employees and representative referred to collectively herein after as SMSA Express subject to the terms and conditions set out hereunder.

**1. THE WAYBILL**

- 1.1. The SMSA Express waybill is non negotiable and the shipper acknowledge that it has been prepared by the shipper or by SMSA Express on behalf on the shipper.
- 1.2. The responsibility of SMSA Express for a shipment accepted under waybill ceases when the consignee acknowledges the receipt of the shipment by affixing this signature on the Delivery sheet.
- 1.3. All shipments under waybill are carried at owner's risk.

**2. SHIPPERS OBLIGATION AND ACKNOWLEDGEMENT**

- 2.1. By tendering materials for shipment via SMSA Express it is deemed that the shipper agrees to the terms and conditions stated herein.
- 2.2. The shipper warrants that he is the owner or the authorized agent of the owner of the goods transported here under and the shipper hereby accepts SMSA Express terms and conditions for itself and/or as an agent for and on behalf of any other person having any interest in the shipment.
- 2.3. The shipper warrants that each article in the shipment is properly described on this waybill and it does not contravene the provisions of the Saudi Postal Act or any law of the time being in force and has not been declared by SMSA Express to be unacceptable for transport as specified under section 12 below and that the shipment is properly marked and addressed and packed to ensure safe handling.
- 2.4. The shipper shall be solely liable for all cost and expenses (which shall without limitations include Surcharge) related to the shipments and for costs uncured either in returning the shipment to the shipper or warehousing the shipment pending such return.
- 2.5. The shipper accept the conditions that the shipment is being carried by SMSA Express from point of rendering only upto the address shown on the waybill and in case this shipment has to be rerouted/redirection/returned for any reason whatsoever the shipper shall pay in advance all charges levied by SMSA Express for such rerouting/redirection/return as per the normal schedule of SMSA Express. SMSA Express will hold such shipments at destination mentioned on the waybill for maximum period of 5 days from the date of shipment. Thereafter SMSA Express reserves the right to destroy the shipment without informing the shipper and the shipper shall indemnify SMSA Express any claim or liability.
- 2.6. Packing of the material rendered for the shipment is the responsibility of the shipper including placement of such materials inside the container supplied by SMSA Express if any, not withstanding anything else stated in these terms and conditions.

**3. SMSA EXPRESS RIGHT OF INSPECTION OF SHIPMENT**

- 3.1. SMSA Express has the right but not obligation to open and/or inspect the shipment.
- 3.2. SMSA Express reserves the right to refuse shipments not confirming to these terms and conditions without assigning any reason whatsoever.

**4. INSURANCE**

- 4.1. While SMSA Express has developed as sophisticated tracking system for all shipments carried in the network and has experienced manpower to handle all shipments. THE SHIPPER may if he so desires insure his shipments at his own costs.

**5. CHARGEABLE WEIGHT**

- 5.1. Every shipment shall be charged by its chargeable weight as defined hereunder and not the actual weight. The chargeable weight shall be higher of (a) the actual weight rounded off to the next higher half Kg as per the rate category agreed to or (b) the volume weight similarly rounded off as in (a) above.
