1.1 This document lays down the return procedures. This procedures covers all activates process of return to Origin.

2.1 This procedure is applicable to all SMSA Employee working with Fulfilment Section Warehouse.

4.0 RESPONSIBILITY

- 4.1 The Supervisor shall be responsible for receiving customer emails and ensure the return process is completed as per the customer's requirement.
- 4.2 The RTS Handlers should be responsible for sorting, palletizing/bagging all shipments as per customer requirements, handing over the shipments to the concerned departments, and applying the proper scans as per the operating procedure.
- 4.3 The Operations Agent should be responsible for ensuring the Handlers are operating as per the standard procedure, and dispatching pre-alerts to concerned departments.
- 4.4 The Data Encoder should be responsible for scanning the original AWBs, generating return AWBs and creating labels.

5.0 SAFETY PRECAUSTIONS

5.1 Wear PPEs such as Safety Shoes, Safety Helmet, Safety Harness, Gloves and etc.

6.0 PROCEDURE

- 6.1 The return process for RTS section is to return the shipment to the shipper.
- 6.2 If the customer requires to return the shipment on the same day, then return the shipment using the same AWB. Put CONS scan for the packages of each individual customer and palletize. Handover the shipments to SFS section to return to Shipper.
- 6.3 If customer requires the packages to complete a certain number of days before being returned, then customer can ask any of below requirement.
 - 6.3.1 Customer shall request to redeliver the shipments.
 - 6.3.1.1 RTS team searches for the shipment.
 - 6.3.1.2 Apply DCON Scan on the shipments.
 - 6.3.1.3 A Label is created detailing the new delivery location and attached to the package.
 - 6.3.1.4 CONS Scan is applied on all the packages.
 - 6.3.1.5 Palletize/Bag the shipments.
 - 6.3.1.6 If the Delivery location is in Riyadh, then apply scan "Handover to ECOM/SFS RUH". Physically handover the shipment to ECOM/SFS RUH and send the pre alert to ECOM/SFS RUH.
 - 6.3.1.7 If the Delivery location outside Riyadh, then apply scan "Handover to line Haul". Physically handover the shipment to Line Haul and get the signature of line haul supervisor on Handover Manifest. Send the pre alert to Line Haul.
 - 6.3.2 Shipper sends the email to come and collect the shipments.
 - 6.3.2.1 If shipment is returned using same AWB, then apply CONS scan the packages of each individual customer and palletize. Handover to SFS for delivery to shipper.
 - 6.3.2.2 If shipment is not returned using same AWB, then the packages of each customers are taken to the work station for the scanning of original AWB with gun scanner and the AWBs number are uploaded on S Panel to generate return AWBs. The Old/Original AWBs are removed and new Return AWBs are attached to its respective packages.
 - 6.3.2.3 If the shipper located inside Riyadh and packages returned in small packages then packages are segregated into SMSA bags and the

CONS scan is applied on the Packages. If packages not returned in small packages then the packages are segregated onto the pallets and the CONS scan is applied on the packages. Then apply the comment scan "Handover to SFS RUH" and send the pre alert to SFS RUH. At last apply COD RTS scan on the original AWBs with comment "NEW AWB"

- 6.3.2.4 If the shipper is located outside of the Riyadh, Print the new AWB with the new Destination on it. CONs scan applied on all the packages and apply the comment scan "Handover to Line haul". Physically handover the shipment to Line Haul and get the signature of line haul supervisor on Handover Manifest. Send the pre alert to Line Haul. At last apply COD RTS scan on the original AWBs with comment "NEW AWB".
- 6.3.3 If customer send email to return the shipments.
 - 6.3.3.1 Follow the procedure mentioned in point 6.3.2.
